- 5. With reference to BSE letter dated 18th January, 2021 for non-submission of the Related Party Disclosure for the quarter ended December 31, 2020 within the period prescribed

Due to resignation of both Managing Director and Whole Time Director of the Company. The Board could not approve the Unaudited Financial Results of the Company for the quarter ended December 31, 2020.
